April Meeting Highlights:


For those of you who may not have made it to our April meeting, here is a summary of what we discussed!

Updates:


- PCC Part B- We submitted our April quarterly report highlighting the work we have been doing in relation to our underage drinking grant!






Current Projects

Drug Takeback Day

On Saturday April 22nd, we partnered with Burlington and Harwinton Resident Troopers, the Burlington Bristol Health District and the Litchfield County Opiate Task force to collect unused medications for disposal! Harwinton collected 11.6 pounds and Burlington collected 18.5 Pounds!

SOR Mini-Grant

We have received the application for our yearly State Opioid Response Mini-Grant offered through our Regional Behavioral Health and Action Organization, Amplify. This application is competitive and only 14 awards will be given out of 48 towns in Hartford County. Through this grant we are able to continue offering opioid prevention education in the community!
